#### Kentucky Medicaid Utilization Management Program

The Cabinet for Health and Family Services (CHFS) Department for Medicaid Services (DMS) has partnered with Gainwell Technologies to implement and maintain a comprehensive Utilization Management (UM) program for Kentucky's Fee-For-Service (FFS) members. The new Kentucky UM program will be supported through innovative technology that will implement a systematic automated prior authorization (PA) approach and reduce the administrative burden on providers that come with paper, phone, or fax processes. This approach will offer a more efficient process that allows a member to begin treatment sooner and allows providers to receive a determination and start services much quicker, which can lead to better patient compliance and reduce complications.

- New utilization management platform Essette features a provider portal, interactive voice response system known as Gabby, and chat functionality
  - Allows providers to receive a determination and start providing services much quicker
